

Announcement of the Publication of the Prospectus Attica Bank S.A.

Attica Bank S.A. ("Attica Bank" or the "Issuer") announces that, as of 17.11.2022, makes available to investors the Prospectus, consisting of separate documents, namely (a) the registration document (the "Registration Document"), (b) the summary (the "Summary") and (c) the securities note (the "Securities Note"), in each case approved by the Board of Directors of the Hellenic Capital Market Commission ("HCMC") at its meeting held on 17.11.2022, constituting all of them a prospectus within the meaning of articles 6 and 10 of the Regulation (EU) 2017/1129, which was drafted in English and includes a Greek translation of the Summary thereof, in accordance with Regulation (EU) 2017/1129, the delegated Regulations (EU) 2019/979 and 2019/980, articles 57-68 of Greek Law 4706/2020, as in force, and Decision 1/892/13.10.2020 of the HCMC (the "Prospectus"). The Prospectus concerns (a) the admission to trading on the Warrants Segment of the Regulated Securities Market of the Athens Exchange (the "ATHEX") of 271,448,946 Euro denominated warrants ("Warrants") issued by Attica Bank ("First Admission") and (b) the admission to trading on the Main Market of the Regulated Securities Market of the ATHEX of 271,448,946 new ordinary registered shares with a single voting right and a nominal value of €0.07 each in the capital of the Issuer (the "New Ordinary Shares"), following the conversion of the Warrants ("Second Admission").

Additional information about Attica Bank, the First Admission and the Second Admission (such as, for example, for the issuance of the Warrants, the process of their transfer and conversion) is set out in the Securities Note and in particular in section 5 «INFORMATION CONCERNING THE SECURITIES TO BE ADMITTED TO TRADING – FIRST ADMISSION» and section 10 «INFORMATION CONCERNING THE SECURITIES TO BE ADMITTED TO TRADING – SECOND ADMISSION».
